The present writing is the transcription of my living word that I, spiritualis homo alive in the living body of flesh, bones and blood also known-said mirella bonavia, have verbally expressed to the men/women (homines) in flesh bones and blood, present in front of me and it is a real declaration of facts, in full truth and here I re-establish that I am what I am, in the present moment manifesting myself in the spiritualis homo (spiritual man) peaceable and peaceful, alive in the living body of flesh, bones and blood also known-said, by the sound of the words, mirella bonavia and I have the authority-ownership of the house, which portion-of-building placed on the ground-floor south side to the right of the stairs, of the real manifestation made of cement and stone bricks, founded on the land and soil of the real place, also known as the Torino hill, before the river also known as the Po-river, defined by the topographical references of the distances from the upper edge of the north-east ridge of my house to the "Campanile della chiesa Madonna Addolorata" of 227.35 m; at the "Campanile del Monte dei Cappuccini" of 2480 m; to the "Campanile della parrocchia santuario Sacro Cuore di Gesù" of 1530 m, henceforth called the royal house, purchased-negotiated by "what part of the seller Salvatore SPARACIO", identified on 2 August two thousand and two (2- VIII - 2002) by the agent of the "ITALIAN REPUBLIC" and the like "Stefano BERTANI, Notary in Rivarolo Canavese, with study in corso Torino n.1, registered in the Role of the Notary College of the United Districts of Torino and Pinerolo, Directory No. 87346 Collection No. 8922"; the aforementioned real house is not an address, it is not a definition, it is not the cadastral, mortgage and similar registration as previously pretendedly and allegedly described below in the name and on behalf of the "ITALIAN REPUBLIC" and similar to the alleged-notary Stefano BERTANI: "in the municipality of Torino, part of the building used as a residential building with entrance from the number 23 (twenty-three) of the strada del Salino, and more precisely from the number 23/4 (twenty-three bar four), composed of: - on the floor land (first above ground) apartment with access from the common courtyard, consisting of entrance - living room, kitchen, two bedrooms, ironing room, two bathrooms and a storage room with access from the courtyard, bordering the common courtyard on two sides and strada del Salino, except others - in the basement there are two cellars, forming a single body bordering on the subsoil of the common courtyard on two sides and with the common corridor, except for the others and the above is registered at N.C.E.U. of Torino on foglio 134 (one hundred thirty-four), mappale 163 (one hundred sixty-three), subalterno 95 (ninety-five), strada del Salino n. 23, piano S1-T, z.c. 4, cat.
